# President's Message: Much to Do as Season's End is Soon Around Corner Door 15; Avalon Hearing Center 8, Dias Stables 7, and GSSA 18, Espanol

We have plenty to do as the end of the season will soon be around the corner.



This has been a season in which so much has gone so smoothly, a tribute to a board of dedicated officers with whom the general membership has shown so much trust. Yet it also has been a wild ride dealing with an ar-

ray of issues, including the need to amend our by-laws.

At our May 21 General Meeting, some in attendance suggested that the vast majority of GSSC members aren't bothering to attend meetings because, generally speaking, they must be satisfied with the way the club is operating.

But this was the second consecutive

meeting where no business could be conducted due to a lack of a 30-member quorum. Be aware that we came close to needing a general membership vote of approval on a timely contract with the concessionaire for our annual picnic at the Sacramento Softball Complex.

The board establishes a budget for the fiscal year running from October to October. The picnic is Sept. 15. Fortunately, the \$4,100 tab being negotiated for hamburgers, hot dogs, salads, beans, cake, beer, etc., is within the range – by about a hundred bucks – allowed in the 2007 budget. If the figure had been much more, it would take a vote of the membership to approve. And, without a quorum, the club could not take such a vote before July. That would be putting a lot of pressure on those working on the picnic.

While no action could be taken at the May 21 meeting, there was plenty of news, which you can read elsewhere in this Dugout Chatter. Meanwhile, let us continue to enjoy the season and play safe. #

## July Meeting to be Action-Packed (Cont'd)

Norton said he intends to propose a bylaw change to reduce the quorum requirement for a general meeting. The 30-member requirement has proven to be a major obstacle and source of severe frustration for those charged with doing the club's business. Twenty-four members signed in on May 21 at the VFW hall on Stockton Boulevard. (The by-laws committee, as reported in the May issue of Dugout Chatter, is comprised of Norton, Henry Low, George Hodsdon and Bill Harvey.)

Norton Won't Seek Re-Election. "It is not my intention to seek re-election as club president," said Norton, who took the job in November following a special election. He said the time demands of this job - it has been a wild year, dealing with a lot of off-the-wall kinds of stuff – have proven to be a heavy burden. "I'd like to come back for another year but I just don't have time. My philosophy has always been that if I can't come up with the time to do a decent job, it is not fair to you guys. I just don't have the time. Unfortunately, for me this job is not timefeasible." First Vice President Alan Piccardo also announced at the meeting that he will not be seeking re-election.

The nominating committee at this writing consists of John Mizerak and Trudy Smartt. They'd appreciate help in compiling a list of members interested in leading the club. (Mizerak: 332-5511.) Mizerak will present a slate of one or more candidates for each of the seven offices at the July 2 meeting. Those desiring to serve on the board must come forward on or before the July 2 meeting. Only Commissioner Dave Vargo and Treasurer Glen Cole of the seven officers have declared their intent to continue serving on the board.

**Picnic Update.** Benny Benson, chairman of the picnic committee (Dante Ciardella and Hank Fontes), said this year's picnic will be "just as good as it

used to be." He added that "we still need volunteers." He said he, Dante and Commissioner Vargo met with the concessionaire at the complex who was "very apologetic" about last year's hassle over costs. The countdown to the picnic: As of June 30, there are 76 days until Picnic Day. The committee was given two prices, \$4,100 or \$4,300, including chicken. Benson said there aren't that many members who prefer chicken. (Want to help? Call Benson: 383-0179.)

Budget Update. Treasurer Cole reported that the club has \$67,977.06 in the bank and an audit report is due at the July meeting. Club leadership reiterated its gratitude to long-time treasurer Doug McCreary, who retired from his dentistry practice and moved to Oregon. It was noted by Club Commissioner Vargo that the Howe Avenue park bill has been paid for just half the year and work is under way on a biennial contract with the City of Sacramento for the complex. A new parks superintendent is due to take office in July, Vargo said, but there has been verbal assurance that there will be no increase of the fee for a day game (\$40) or a night game (\$50).

Bats will be "Watched." Vargo said the complex director, Don Barney, will be observing usage of bats, with the possibility that some popular bats (such as the Miken Freak or Easton Synergy II) could be allowed at the complex in 2008. The city has the right to allow an ASA non-approved bat, as long as players aren't hitting balls onto the U.S. 80 freeway from Field #1, Vargo said. ASA issued a notice last November that the Freak would no longer be allowed as of January 2008. However, if a bat is on the February 21, 2007 ASA nonapproved list, it cannot be used. Vargo said the next update from ASA on what bats are "illegal" is not expected before next year. The ASA list with photos and descriptions is available at the ASA website and on the complex bulletin board near Field #1.

**No Raffle This Year.** Nobody stepped forward to organize a raffle, so there

will be none in 2007, Norton announced. The need for a volunteer was noted in the May Dugout Chatter. The club is financially fit without the raffle income, he said.

One-Pitch Tourney Update. Player Agent George Hodsdon reported that while there were plenty of "enthused" members, only 12 bothered to sign up for a proposed one-pitch tourney on May 29. Such a tourney in the future might be scheduled on a Friday morning, rather than during the week of the Reno tournament, he said. #

We have two assignments: "A" is permanent and "B" is temporary for a person on injured reserve. Players returning from IR always go back to the original team and the temporary player goes back on the waiting list. (This is to prevent a player from faking an injury so he can get on another team when he returns.) #
