NOMINEES FOR GSSC BOARD POSITIONS ARE PRESENTED AT JULY MEETING; ELECTION AT AUGUST CLUB MEETING

JULY 2008

Heat, Smoke Cancel Games

GSSC directors on July 7 agreed to cancel night league games of July 8, 9 and 10 due to a forecast of dangerous air quality conditions from a heat wave combined with wildfire smoke. The action followed a call from the softball complex director that games of July 8 and 9 were not likely to be played due to the unhealthy air. League 2 (9 a.m.) games of July 8 were played, but it was decided to cancel the League 6 (10:30 a.m.) contests.

The board also approved President Dan Norton's motion to include July 10 in the cancellation decision. Further, the board authorized the club commissioner and club president to determine whether future games would be canceled due to any unsafe conditions, be they fields that are too wet or unhealthy air quality.

Members were encouraged to call the club answering machine for news on the playing schedule when skies are smoky, not just when rain is occurring or in the forecast. Norton, a firefighter for 32 years, said he could not recall so many fires this early in the fire season. He warned that there may be a need to make weekly determinations on the playability of GSSC games as such major fires as Big Sur may not be doused until the end of July. Outdoor sports have been canceled in a number of Northern California counties.

Other news: The board reiterated the requirement that members wear official GSSC hats.

Player Agent Tom Sansone said a looming player shortage in League 1 (Mondays) could be relieved if eligible 70-year-olds and older who are playing in other leagues would consider signing up for Mondays, too. # Members on July 7 approved the nomination of a slate of officers for the 2008-09 fiscal year, presenting a choice between Frank Bettencourt and Ray Mendonsa for president.

When members vote on Aug. 4, there will be only one nominee for each of the six other offices that comprise the organization's Board of Directors.

The slate of nominees was presented by John Mizerak, nominating committee chairman. He thanked his committee of Trudy Smartt, Mark Cordell and Ken Cramer. The new board will be sworn in at the general meeting held in conjunction with the annual picnic and playoff day on Saturday, Sept. 20.

Bettencourt is a former player agent who plays in Leagues 2 and 6. Mendonsa, a L4 player and L5 umpire, is in his second year with the club. They seek to succeed Dan Norton, who is not running for a third term. He pledged to help and support either candidate.

Mendonsa told those attending the general meeting in the north area VFW Hall that while he is relatively new to the club, he has had experience as president of Parkway Little League with an annual budget of \$150,000. He said he would bring a "very open mind" to the post, believing in the "committee style of leadership." He said, "This is all for the members, not the board (of directors), and for people who want to play and enjoy the game."

Bettencourt was not present at the general meeting where candidates were invited to give brief remarks.

Also not seeking re-election is Club Commissioner Freddie Miller. Current First Vice President Dave Vargo has agreed to run for club commissioner, a post he held in 2007.

Nominated for first vice president, a post responsible for overseeing the club's team sponsorship program, is Fred Fischer, a L2 manager.

HOT WEATHER ALERT

Heat Emergencies: Drink ample (every inning if necessary) portions of water during hot days, even if you are not feeling thirsty! Heat Cramps: Painful muscle spasms in legs and abdomen. Heat Exhaustion: The body's cooling system is becoming overwhelmed. Signals include headache, nausea, dizziness, weakness, faintness, fatigue, feebleness, heavy sweating and perspiration. Heat Stroke (Life-threatening condition): The body's cooling systems are now overwhelmed by heat and have stopped functioning. Signals include red, hot, dry skin; vomiting; changes in level of consciousness; collapse. Care Procedures: Move to cool

Care Procedures: Move to cool area; loosen tight clothing; remove sweat-soaked clothes; apply cool, wet towels; fan the victim, and, if the victim is conscious, give small amounts of cool water.

Emergency: If victim refuses water, vomits or starts to lose consciousness, call 9-1-1 immediately! Place victim on his/her side; continue to cool him/her (use ice packs on wrists neck, armpits, groin and ankles). Check for signs of life (breathing, circulation, pulse). — Safety Chairman Jerry Jodice #
