JULY 6 MEETING: NOMINEES FOR AUG. 3 ELECTION

Membership will elect a new board of directors at the Aug. 3 general meeting based on nominations for the seven posts that were presented at the July 6 meeting. President **Ray Mendonsa**, Treasurer **Glen Cole**, Player Agent **Tom Sansone** and First Vice President **Fred Fischer**, responsible for team sponsors, are unopposed for re-election.

Dick Latimer and **Bob Smartt** were nominated for the office of club commissioner, which has been vacated by Dave Vargo for health reasons, and is temporarily filled by Freddie Miller. Second Vice President **Pete Ward**, responsible for uniforms, is on the ballot for re-election. **Doug Gedestad**, 56, a L5 player and club member since 2008, also was nominated for the position.

George Lamb, 56, a League 5 shortstop and club member since December 2005, is unopposed for club secretary. The current secretary, Mickey Schleicher, moved his primary residence to Nevada and is unable to continue on the board.

Nominations of Smartt and Gedestad were made from the floor before John Mizerak, nominating committee chairman, closed nominations.

Latimer, 66, joined the club on Nov. 30, 2007 and currently is in non-playing membership status as he recovers from back surgery. He is retired as an engineering professor at the University of Louisville, where he was active as an ASA umpire assigner and treasurer of the ASA affiliate in Louisville. He said he has experience as a member of boards of directors of baseball (American Legion) and softball organizations in Kentucky. He served as umpire in chief. He said he hopes to be able to play ball next year and, if elected, dedicate most of his time to being the club's commissioner. "I promise to give 110% to the position," he added.

Smartt, 55, is in his sixth year with the club and has been active as a team manager and, with wife Trudy, as the club's Sunshine and Health Committee chairs. Bob currently plays in all three night leagues and manages a team on Wednesday nights. He is manager of maintenance and repair services for the newly formed Twin Rivers Unified School District. He held a similar position with the Rio Linda School District, for which he worked 27 years.

Club commissioner duties include appointing league commissioners, enforcing club playing rules, and dealing with league playing or personnel issues that require board-level attention.

The Aug. 3 meeting will be held at the VFW Hall at 2784 Stockton Blvd., beginning at 7:30 p.m. The new board will be sworn in at the club's Sept. 19 meeting.

Other news from the July 6 meeting, which was well-attended:

ASA vs. SSUSA. Discussion of whether the club might switch from the Amateur Softball Association to Senior Softball USA for governance was postponed to the August meeting, when a representative from ASA's Greater Sacramento Softball Association is expected to make a presentation. SSUSA has already made a presentation and arguments on both sides have been published in the Dugout Chatter (June issue), which is online at www.gsscs.org. (See Page 2)

Uniforms. Ward said the new uniforms issued this year are of a cooler and faster-drying polyester material that "appears to be holding up pretty well." More of these jerseys will be phased in next year. Speaking of league championship awards, Ward said each player on a championship team will get a special t-shirt and hat right after the Sept. 19 games. Championship jackets can be ordered for \$17 more per player, he added.

Insurance. Player Agent Sansone noted that the club now has a \$2 million liability insurance policy good through the rest of this calendar year. The policy was provided free of charge by SSUSA. It was recently discovered that the \$25 per team fee to the Complex pays for the Complex insurance and neither the club nor its players has been insured through ASA, as many had believed. This insurance, valued at more than \$6,000 per year, will be included in the 2009-10 club budget, which could have some impact on club dues. President Mendonsa said the decision to accept the SSUSA insurance offer for 2009 does not bind the club to continue the coverage through SSUSA next year or to choose SSUSA over ASA as a governing body.

Facilities. The club formed a committee of the board to negotiate with the Complex for use of fields in 2010. The board also has been in contact with the contractor in charge of the Freedom Park softball fields at the former McClellan Air Force Base. Mendonsa has reiterated that any decision to move any of the GSSCS leagues from the Complex requires substantial support of the club's members.

Safety & Respect. Acting Club Commissioner Freddie Miller, who also supervises umpires, said there appears to be "a lot of confusion" as players in Leagues 3, 4 and 5 "don't want to read the rule book." He said there continues to be a problem of players "not running wide" to avoid contact with the middle infielder making a play at the base. Players risk ejection, he said. Also, he said there have been instances of "disrespectful" behavior toward umpires. Warnings have been issued, he said. On the issue of bats and balls, he said that "we're researching" what is available to give Golden Seniors "the best bang for the buck next year." #
