GSSC MEMBERS ELECT 2010 BOARD OF DIRECTORS

The 2009-2010 Golden Seniors Board of Directors was elected at the Aug. 3 general meeting, including the unopposed re-elections of President Ray Mendonsa, First Vice President Fred Fischer, Second Vice President Pete Ward, Treasurer Glen Cole and Player Agent Tom Sansone.

Bob Smartt was elected to the post of club commissioner (beating Dick Latimer in the only contested election). George Lamb was uncontested for the job of club secretary. All will be sworn in at the Sept. 19 general meeting held in conjunction with the annual club picnic/league championship playoffs at the Sacramento Softball Complex. (Note: Doug Gedestad had been a nominee for second vice president, but withdrew. Descriptions of board members' responsibilities are on the back page.)

Other news from the Aug. 3 meeting:

ASA vs. SSUSA. Following a presentation and Q&A session with a representative of the Amateur Softball Association (Greater Sacramento Softball Association), Mendonsa said he intends to have the question of GSSC governance decided by a vote of the membership. Ballots would be mailed to all members and the result would be announced at the November general meeting. (See Page 2)

SEPT. 19 PICNIC WILL BE SPICED UP WITH LIVE MUSIC

Dante Ciardella won club approval at the Aug. 3 meeting to "spice up" this year's Sept. 19 picnic with live music. It was felt that the picnic had become "too dry," Dante told the Board of Directors, which put the question to the membership. A 12-9 vote approved the \$580 expenditure.

The band is led by George Bruno, whom Dante said specializes in music of the 1940s and 1950s, so get ready for the first tune, which Dante said he expects to be "In The Mood." Dante said there is even a concrete area where some may want to dance. The band, including a singer, will perform from about 11 a.m. to 2 p.m. or perhaps longer. The picnic, which will include fried chicken as well as quarter-pound burgers and hot dogs -- and beer -- also will feature a table for members (or their wives) to bring a dish to share.

Ciardella also told the club that Benny Benson is actually in charge of the picnic -- if anything goes wrong. Benny did not comment on that, but he requested notice in the Dugout Chatter. They also seek volunteers to help. Call Dante at 453-1921 or Benny at 383-0179 if you can help. There is no charge for members, wives/husbands, or sponsors and their guests. There is a \$6 fee for members' guests and kids over 7. #

The ASA's regional chief umpire, Dave Maudsley, defended the no-exceptions requirement to use only ASA-certified bats and 44-core balls. Bat handles could be double-wrapped, but no thicker. Bats that predate the ASA standards of 2000 are allowed at the discretion of the umpire. Bats "dented" or otherwise deemed unsafe are disallowed.

Mendonsa said that the club could still opt for Senior Softball USA-provided insurance and play at the Complex, but would not be allowed to use non-ASA-approved bats such as the Miken Freak or Ultra II. Maudsley urged the club to carefully consider the levels of coverage and costs of ASA-provided insurance, including a policy to protect club officers who could be named in lawsuits. The board earlier this year purchased insurance from SSUSA for the current calendar year after discovering that the Complex fees included insurance for the Complex, but not the club officers or its members. (Board members noted that the SSUSA policy covered ambulance costs for an injured player, while the ASA policy would not.)

Maudsley vehemently defended the ASA equipment standard that limits the speed of a batted ball to 98 miles per hour as within the reaction time of the average fielder playing softball. He also said that ASA has had to impose a strict re-testing and re-certification process because companies have made bats that pass initial tests but get hotter as they are broken in. Safety is the primary concern, he said, asking how the GSSC's leaders would feel if they allowed a non-ASA-approved bat that resulted in serious injury or even death to a fellow player.

Advocates of SSUSA governance (that would still not allow use of the better bats at the Complex) say older players lack the swing speed of the machines used in testing, and the combination of weak bats and low-compression balls has diminished enjoyment of the game. They also say the ASA-approval process has driven up the cost of bats that are allowed at the Complex. (See League 7 Commissioner Larry Campbell's arguments for SSUSA governance in the June 2009 issue of Dugout Chatter, as well as an ASA response by Jeff Dubchansky to SSUSA's pitch to the club board and members at a meeting last spring. At any rate, Mendonsa stressed that such decisions must be made by the membership, not the board of directors, and he is looking to have the matter settled at the November general meeting. Mendonsa said the GSSC decision on insurance would not allow one or more of the club's leagues to branch off from a decision to use ASA or SSUSA. At the Aug. 3 meeting, Mendonsa, who is an ASA-certified umpire, said he believes the "founding fathers" of the GSSC intended the club to be a "recreational" experience. He said those who want to hit overthe-fence home runs on a regular basis are primarily tournament-level players who are able to use hot bats in those venues.

2010 League Fees. Player Agent Tom Sansone reported that he is working on the applications for 2010, including cover letters, but the Sacramento Complex has yet to provide an updated list of field fees. (Complex officials have told the board that 2010 fees would increase very little, if at all, but they apparently don't have the final say.) Sansone said the club cannot "look at other fields until the Complex is ruled out." He also said that the Howe Avenue venue for L1 will not be changed. #
