## **NEW YEAR BRINGS TALK OF MAJOR CLUB ISSUES**

Concerns were voiced at the Jan. 4 Golden Seniors Softball Club general meeting over lagging player signups for most GSSC leagues and the impact on the club's finances for the coming season.

Except for Monday day 70+ (League 1) and Tuesday night's L3 (50+), leagues were 30% to 40% short of players for 2010.

Club leaders urged members to help stimulate more interest in the Wednesday and Thursday night leagues for 50 and over players and the competitive select Tuesday morning leagues for players 60+ and 75+. (See Page 2)

#### NEW YEAR BRINGS DISCUSSION OF BUDGET; LAGGING PLAYER SIGNUPS

The club's board of directors -- President Ray Mendonsa, 1st VP Fred Fischer, 2nd VP Pete Ward, Treasurer Glen Cole, Secretary George Lamb, Club Commissioner Bob Smartt and Player Agent Tom Sansone -- scheduled a special board meeting in late January to more thoroughly examine the club's options when closer to final pre-draft player numbers are known.

The board is expected to report and act at the next general membership meeting at 7:30 p.m., Monday, Feb. 1, at the VFW Hall, 2784 Stockton Blvd.

Among potential solutions to nagging problems: Fewer teams in leagues, even fewer leagues, and reduced costs for umpires and scorekeepers. Such steps may be necessary if player signups -- renewals and new players -fall short of providing income needed to meet projected expenses of operating seven leagues with more than 400 players.

Treasurer Glen Cole reported that the club had \$47,700 in income so far this year, nearly all from dues, and the budget (for the fiscal year October 2009 through September 2010) calls for \$68,500 in income, \$58,200 from dues. Of dues income, \$43,596 had been realized as of Jan. 4. Budget expenses are projected to be \$66,000, with the largest items field rentals (\$25,000), umpires (\$11,500), and the picnic (\$4,000). Team sponsor income is pegged at \$9,000, of which \$6,000 was still to be received.

Meanwhile, Mendonsa reported that he has had difficulty contacting Complex officials to nail down and sign a contract for use of the fields this year. Complex officials have told the board that no significant increase in field fees would occur for 2010. (See Page 3)

**Player Signups Report.** Player Agent Sansone reported 130 members from 2009 had not mailed in their renewals. Was the increase in dues an issue? Sansone said this does not seem to be the case based on telephone contacts with these players. He said most of them say they had "put applications aside and forgot, or they said, 'I thought my wife took care of that.""

Sansone said L1, which fielded nine teams in 2009, had 123 signups for the Monday morning league for those 70 and older. That league is nearly fully subscribed, and the same could be said for L3 (50+ coed) on Tuesday nights.

A six-team league needs 78 signups and a four-team league needs 52. As of Jan. 4, six-team L3 had 73 signups. L2 on Tuesday mornings for age 60+ players, had 74 signups, but that would not be close to filling the 96 player slots for an eight-team league.

League 4 (Wednesday nights) and L5 (Thursday nights) have 47 and 50 signups, respectively. L6 and L7, which are select competitive leagues for players 60+ and 70+ on Tuesday mornings, both have 38 signups as of this writing, and each needs 14 more for a full four-team league. Through December, 443 roster slots were filled, including 181 by 79 multi-league players. In 2009, 110 multileague players accounted for 250 roster spots, according to Henry Low, who maintains the club's player data base. Low observed that a reduction in multi-year player signups might be a result of higher dues and the economy. Members pay \$115 for one league and \$90 for each additional league. That is up from \$95 and \$70 in 2009. Life members' dues are somewhat less. (See Page 4)

Experimental League News. Larry Campbell, the driving force behind the creation of L7 in 2009, is organizing a new league for players 75 and over. He reported that he has enough for two teams and is still recruiting players to hopefully have a fourteam league for Thursday morning games at Carmichael Park. This league will be evaluated to determine if it will become a league within the Golden Seniors club. Campbell said the "good news" is that "several players who had dropped out are coming back for this older league."

New Members. Sansone said there were 18 new members so far. The club had more than 50 new members in 2009, mostly signing up during the season. Player applications are available at the club web site, www.gsscs.org.

New Player Tryouts. Workout dates for new players, or for players switching leagues, will be scheduled in early February, Smartt said. Expect an announcement by the Feb. 1 general meeting, he said, as he discusses availability of a field with the Complex.

Sponsors. First VP Fischer reported that 15 sponsors had paid for 2010 and three sponsors had dropped out. He said he had three potential sponsors at the time of the Jan. 4 meeting. (See Fischer's column elsewhere in this newsletter.)

Safety Coordinators. Jerry Jodice, the club's safety chairman, said it is imperative that each league's commissioner designate a safety coordinator. He also lamented the lack of signups for safety training, forcing him to cancel Jan. 9 and Jan. 11 safety classes. (See Jodice's safety column elsewhere in this MARK WHITE, DDS newsletter.)

Uniforms. Second VP Ward said he could upgrade caps for \$1 more apiece, and the board endorsed his proposal.

Life Members. Ten members will be inducted as life members at the Feb. 1 meeting. The list of those meeting requirements for age and membership tenure was unanimously approved. They are Louis Cerutti, George Crowl, Dick Gustin, Jerry Jodice, Jim Lamm, Dick Reisinger Sr., Bob Silvis, Joe Smith, Al Tirapelli and Arnold Wilkerson. Cake and coffee will be served in honor of these folks, who will be introduced by the tuxedoed emcee, Jim Lortz.

2010 Club Picnic. The board stressed that steps will be taken to rein in costs of the annual picnic, including consideration of contracting for catered meals from a GSSCSsponsoring restaurant. Club directors have been unhappy over the cost of the 2009 picnic that amounted to about \$30 per person. #

#### TEAM SAFETY COORDINATORS ARE NECESSARY FOR EACH LEAGUE

#### From Jerry Jodice, safety chairman

Safety procedures are NOT being enforced during all league games. During the first few hours of 2009 GSSCS championship games, the safety cart was unavailable and not in its proper place for any emergency service. Our players need to have this simple procedure adhered to during all league games. Only League 1 (Monday) umpires refused to start a game without the safety cart available this past 2009 season. All league commissioners should establish that their umpires are expected to follow this same requirement for every game. The club may be liable if the safety cart is not available for any emergency.

**Each league needs a Safety Coordinator** to guarantee that all safety procedures are faithfully supported during every softball season. The league coordinator should meet with the club safety chairman and the other league Safety Coordinators at least twice during the season to review safety procedures and supplies and make improvements as necessary. My recommendation is that the Safety Coordinators meet with the safety chairman in February, before the season begins, to assure that each league is fully prepared to play. Safety procedures are NOT EFFECTIVE without team coordination.

#### SAFETY REQUIREMENTS PRIOR TO THE 2010 SEASON

1. League Safety Coordinators should meet with the club safety chairman to assure that the club addresses every issue that may occur throughout the season.

2. League Safety Coordinators may wish to reorganize or improve safety procedures each year.

 League Safety Coordinators should contact team managers within their league to see that each team has one or more safety crew members to work with during the season.
Safety Crew members meet with their league safety coordinator to review procedures and assure that all necessary supplies are within the safety cart before season begins.

5. League Safety Coordinators should recommend to the club president the person they may best work with (in the following year) to improve safety procedures and supplies.

#### SAFETY PROCEDURES BEFORE EVERY GAME

Safety Crew members must be designated by team managers to coordinate the safety procedures before each game.

Safety Crew members are to make certain the safety cart is checked and in place before each game.

The AED (defibrillator) must be checked for OK status before games begin! Safety Crew members are to make certain the safety art is returned to the park office after the last game. #
